Chairman's Report 2019/20 - To be presented to AGM 29 February 2020.

Manvers Waterfront Boat Club – one of the best open water swimming venues in the UK and one of the largest canoe clubs in the country! I would like to thank all its members, coaches, leaders and helpers that have made this possible.

This has been made easier with the great facilities we have at Manvers. This year we have completed improving the club office and meeting room. We have also purchased more equipment and updated some of our older equipment. We are currently still working on improvements of the slalom pond; disabled fishing pegs and we have purchased more new fish which we are hopefully settling into their new home.

Your committee met 10 times in 2019 with various sub-group meetings in between. Membership has settled at around 950 paid up members and we are in a sound financial position.

The club sections have thrived, with all sections reporting much more activity having section meetings and section representatives reporting back to the committee. All sections are maturing and attracting members and have busy programme ahead.

Our mission - To encourage participation across all sections.

We will achieve this by:

- Promoting the Club.
- Providing clear accurate information about the club and our programme,
- Being a friendly, supportive club, welcoming and supporting people of all abilities, younger members and families.
- Providing safe equipment and activities
- Providing clean, well maintained facilities
- Providing accessible, exciting programmes
- Supporting members and volunteers

I can see that the 2020 is going to be another great year for the Club.

Club Users:

We record the number of people that use the building this includes Café users and people that hire rooms etc. This was about 50k last year!

Our solar panels continue to provide lower cost electricity to the building in which help save the environment and reduce our electricity bill.

The priority this year remains, providing an interesting and accessible programme across all sections for its members and visitors.

Our Webcollect members portal is helping members manage their membership easier and quicker. This enables the Club to better manage bookings and activities which links into our finance systems this has helped greatly reduce the number of Volunteer hours needed.

We have completed the work on the new office and meeting room. The extra room has helped all sections of the Club develop and expand.

2019 saw the formation of a Dragon Boating section here at Manvers, we may even be able to add further sections in the coming years.

The Trust, who manage the lake and boathouse wish to continue to improve the boathouse facilities throughout 2020. We have improved the lighting throughout the building and installed additional hand dryers in the toilets. We have added to the CCTV system to increase security to the building and surrounding areas. We have also installed a PA system that will have a range of benefits to the boathouse. The car park is still a priority and we look towards phase 3/4 to resurface the car park and installing the first floor of the new building when finances allow.

All that the club has achieved last year would not have been possible without the support of you the members, volunteers, coaches, section heads and the Committee. The club relies on a relatively small number (who are all volunteers) to keep the club running and delivering a busy program year-round. This band of people enables the club to function and keep your membership fees as low as possible; to them all we owe a massive thank you. I do not wish to name specific individuals, you know who they are. THANK YOU.

Balance Sheet 2019/20 MWBC

Our financial year end is 31 January 2020; the accounts go to the Accountant after this date, so the information below shows the **unaudited** income and expenditure for the last 12 months.

The club appears to be on a sound financial footing; however, we do wish to increase our cash reserves to better protect the club as our income can be seasonal in nature.

We donated £17k to the Trust towards improvements and running the boathouse.

The club spent over £23k on maintaining equipment and purchasing new. Having ample, good safe kit remains a priority and helps the club grow and operate safely.

The club also supported its volunteers and coaches, including supporting its coaches and volunteers on up-skilling to help the club grow and operate safely.

We also need to continue to make provision for replacing equipment as it gets worn out through the use it gets and if we wish to offer more coaching at the club the committee will consider the best ways of funding these.
